PUBLIC NOTICE
REQUEST FOR PROPOSALS

Pursuant to Act No. 72 of September 7, 1993, as amended, the Puerto Rico Health Insurance Administration (PRHIA or ASES, by its Spanish acronym) requests competitive proposals from interested insurance companies or other approved health care organizations that meet the Centers for Medicare and Medicaid Services (CMS) definition of a Managed Care Organization (MCOs) interested in providing services as an MCO in the New Model of the P.R. Government Health Plan (GHP).

All entities interested in obtaining a copy of the RFP and Data Book must submit on or before **February 16, 2018** a request via email to PSG-RFP2018@asespr.org. The request must be accompanied with a certification from the President, CEO or highest ranking local officer of the entity stating the interest of the organization in submitting a proposal, that it possesses the necessary legal and financial capacity, and the contact information of the person authorized to request the RFP. The email request must include the certification, as described above, and the evidence of payment.

The RFP and Data Book have a non-refundable cost of ten thousand dollars (\$10,000.00) payable by manager's check, certified check or money order in the name of ASES. Payments in cash will not be accepted. Payment must be made at the Finance and Administration Office of ASES from **February 9-16th, 2018 from 8:00 AM until 4:00 PM (AST)**.

The Mandatory Preproposal and Actuarial Conferences will be held on **February 23, 2018 from 9:00 AM until 4:00 PM (AST)** at the Office of the Fiscal Agency and Financial Advisory Authority of Puerto Rico ("AAFAF" for its acronym in Spanish) located at:

Interested entities will have until **February 22, 2018 at 4:30 PM (AST)** to submit to ASES the Acknowledgement of Receipt of RFP Form (Appendix A of the RFP). Only the representatives of the entities that submitted a timely Appendix A will be allowed to participate in the Mandatory Preproposal and Actuarial Conferences. A maximum of three (3) representatives from each organization will be admitted at the mandatory conferences.

The proposals must be submitted via secure web site no later than **April 6, 2018 before 1:00 PM (AST)**. The individual credentials to access the secure web site will be provided after receipt of Appendix A.

ASES will only consider proposals from entities that: (1) purchased the RFP and Data Book; (2) submitted a timely Appendix A; (3) participated in the Mandatory Preproposal and Actuarial Conferences; (4) submitted with the proposal a Proposal Bond in the amount of one hundred thousand dollars (\$100,000.00); (5) submitted a timely complete Proposal at the "Secure Share Site" established by ASES for this purpose.

ASES reserves the right to cancel or modify this RFP, reject any or all proposals and award contracts that includes the most favorable conditions for the Government of Puerto Rico at the PRHIA's sole discretion.
