AMENDMENT TO EXTEND CONTRACT FOR THE PROVISION OF PHYSIC DE BEHAVIORAL HEALTH SERVICES UNDER THE GOVERNMENT HEALTH PLA **PROGRAM**

WHEREAS, the Administración de Seguros de Salud de Puerto Rico ("ASES") and Molina Healthcare of Puerto Rico, Inc. (the "Contractor") have executed a Contract for the Provision of Physical Health and Behavioral Health Services Under the Government Health Plan within the Commonwealth of Puerto Rico for the East and Southwest Service Regions, (hereinafter referred to as the "Agreement");

WHEREAS, ASES and the Contractor (together, "the Parties") had agreed to extend the term of the Agreement for a period of three (3) months to expire on September 30, 2017;

WHEREAS, the Parties have agreed to again extend the term of the Agreement for an additional period of two (2) months to expire on November 30, 2017; and

WHEREAS, all provisions of the Agreement will remain in full force and effect until such time it is amended by mutual written consent.

THE PARTIES HEREBY EXTEND the Contract for the Provision of Physical Health and Behavioral Services Under the Government Health Plan (the "Agreement") for a second additional term of two (2) months to expire on November 30, 2017, unless the Centers for Medicare and Medicaid Services ("CMS") approves the actuarial certification and further amendments to the Agreement at an earlier date, in which case the Parties shall execute the finalized amendment to the Agreement within five (5) days of such approval.

Until the Agreement is further amended by mutual written consent of ASES and the Contractor, all provisions of the Agreement will remain in full force and effect, including the terms of the physical and behavioral health services provided under the Agreement and current Per Member Per Month ("PMPM") Payments set forth in Section 21.1.1.1 of the Agreement. However, ASES hereby acknowledges that it will honor and pay PMPM Payments that will be later revised and incorporated into an amendment to the Agreement during this extended term, subject to receiving actuarial certification and approval by federal and state regulatory authorities as required by law. The Parties shall begin to reconcile any differences in the current and revised PMPM Payments within thirty (30) days of receiving such actuarial certification and federal and state regulatory approval of the revised PMPM Payments.

Due to the exigent circumstances presented by Hurricane Irma and Hurricane Maria, the Parties hereby acknowledge and agree that any state law requirements for this Amendment shall be satisfied as soon as circumstances allow. This agreement shall be effective from October 1st, 2017 until November 30, 2017. This contract amendment is estimated, but not capped, at \$100 million.
